

The Chariton Community School Board met in regular session on April 9, 2018, in the Administration Office Board Room. A public hearing was held at 6:27 p.m. to receive public comment regarding the proposed tax levy rate. No one was present to address the board. The public hearing was adjourned. The regular meeting was called to order by Board President, Craig Scott, at 6:32 p.m. Board members present were: Craig Scott, President, presiding, Dave Rich, and Dusty Cain. Action Items:

Mr. Rich made a motion to approve the tax levy rate of \$14.60, as published, for the 2018-2019 school year. Motion carried 3-0.

Mr. Rich made a motion to approve a 3-year agreement with CCEA, which includes a 3% total package increase each year. The contract will be in effect until June 30, 2021. Motion carried 3-0.

Consideration of a contract agreement with AFSCME was tabled, as the union has not met to ratify their contract yet.

Mr. Rich made a motion to approve the final reading of Board Policy 206-217 of the policy manual as presented. Motion carried 3-0.

Mr. Cain made a motion to approve a proposal to add an Indian Hills Community College (IHCC) Construction Trades Academy for a two year commitment. Motion carried 3-0.

Mr. Rich made a motion to approve a 3 year commitment with Jostens as the exclusive high school yearbook provider with a proposed budget of \$11,800, with a cost of living increase set each year (usually 2-3%). The fees will be paid out of the yearbook activity account using fundraising and fees to students for the purchase price. Motion carried 3-0.

Mr. Rich made a motion to approve a resolution to oppose the 2018-2019 property tax backfill elimination bill. Roll call vote was taken with all members voting aye. Motion carried 3-0.

Reports:

Superintendent's reports, Principals' reports, and Committee reports were given.

Mr. Rich made a motion to adjourn. Motion carried 3-0. The time was 8:01 p.m.
