May 10, 2021

6. Secretary's Reports and Bills

Board Presentation

Jim Huse from DLR was present to address the board on a proposal to fix Middle School building issues.

Action Items

Ms. DeHoedt made a motion to approve the Class of 2021 graduates. Motion carried, 4-0.

Ms. Willis made a motion to approve the 2021-2022 registration fees. All fees are as follows: Student Activity Tickets, \$45, Adult Activity Tickets, \$95, K-5 Textbook fee, \$30, 6-12 Textbook fee, \$40, 6-12 Technology fee, \$0, Family Cap (not to exceed for required fees), \$200. Motion carried, 4-0.

Mr. Aulwes made a motion to approve 2021-2022 Nutrition prices. The prices are as follows: Reduced price breakfast for students, \$.30, Full price breakfast for students, \$1.95, Full price breakfast for adults, \$2.40, Reduced price lunch for students, \$.40, Full price lunch for students, \$2.90, Full price lunch for adults, \$3.95, Semester milk for elementary, \$36.00 or \$.40 per carton. It was also noted that meals for FY 2021-2022 will be paid by the State of Iowa. Motion carried, 4-0.

Ms. DeHoedt made a motion to approve the contract agreement with AFSME for the Classified Staff for FY 2021-2022. Classified staff will receive a 2% increase in each category. Motion carried, 4-0.

Mr. Aulwes made a motion to table the recommendations for Administrator and Director salaries for FY 2021-2022. Motion carried, 4-0.

Ms. Willis made a motion to approve Cardinal Community School District joining the South-Central Conference. Motion carried, 4-0.

Mr. Aulwes made a motion to approve the request to transfer the balance of the School Educational Foundation to the Scholarship Foundation account at SCICF. Motion carried, 4-0.

Ms. DeHoedt made a motion to approve the bid from Wood Roofing for the Columbus roof, sections B and C. The amount of the bid is \$45,078. Motion carried, 4-0.

Ms. Willis made a motion to approve the replacement of the Van Allen walk in freezer for \$72,000, pending approval by the insurance company. Motion carried, 4-0.

Mr. Aulwes made a motion to exclude students utilizing virtual learning from participating in sports, in FY 2021-2022, unless there is a medical waiver, approved by the board. Motion carried, 4-0.

Ms. DeHoedt made a motion to approve adding coach(s) for Middle School Softball, pending qualified candidates. Motion carried, 4-0.

Discussion Items

Mr. Achenbach led a discussion on graduation for 2021 to determine which board members would be able to be in attendance.

Mr. Achenbach led a discussion on the Return to Learn Plan. Students will continue with masks for the remainder of the school year.

Mr. Achenbach led a discussion about board meetings being held by zoom going forward. The optional zoom will remain in effect.

Mr. Achenbach led a discussion on out of state travel for the elementary administrators. Last year's approved out of state travel was postponed due to Covid and will be happening this year.

The Principal and Superintendent reports were given.

Mr. Aulwes made a motion to adjourn. Motion carried, 4-0. The time was 8:08 pm.
