The elementary has partnered with the Mid-Continent library to encourage reading. Library card drive resulted in 45% additional students have access to the library. AIMSweb testing results very favorable. State assessments will be online this year. Grades 3, 4, 6 and 7 will have less than 2 days of testing and grades 5 and 8 will have approximately 6 days of scheduled testing.

Mr. Tarwater reported that the Courtwarming game was very well attended. The basketball teams start district play February 21st and will participate in the Midway tournament February 10th. District wrestling

will start Friday. The End of Course testing will be online this year. All Juniors will take the ACT on April 28th. The high school just finished a unit on the '60s. The staff at the high school has developed CSIP belief statements.
