Mr. Tarwater reported that the enrollment is up in the high school as the seventh grade class is bigger than the graduating class of 2015. Fall sports are going strong. All teams are working hard in their competitions. The five new teachers are already making an impact in the school. ACT preparation is going to be a priority at the high school this year.
