- District Mrs Butler discussed the process that schools are going through to decide how to reopen the school. The Missouri School Board Association has issued their recommendations. Daycare will reopen June 1st with students that were already enrolled during the 2019-2020 school year. Summer school will be offered starting in June with some online classes. Seated classes will potentially begin July 6th. At this time 72 students are enrolled in summerSchool. Adaptations will be made as information is received from the state, health departments, and DESE.

GraduationGraduation will be July 28th, but Abundant Life will not be available at this time.CeremonyA Committee will be formed to weigh options for having the ceremony in either the gymnasium or football field.

Mrs. Butler provided some information regarding the budget preparation process. Some large technology purchases will be made at the end of this year to make sure we have all the software and hardware needed. Mrs. Butler will be filling out an AMI (Alternative Methods of Instruction) application which can help with distance learning in the future. Both building are working through student pickup, enrollment and close out for both students and teachers. Currently there are still 6 spots open in the preschool program for the 2020-2021 school year. Kindergarten screenings are being scheduled for the last week of July. Staff have started enrolling in their new insurance options. United Healthcare and MetLife will be our providers next year.
