Construction Update

Universal has created posters to try to get local participation of tradesman. The pre bid meeting will be October 15th and bid opening will be October 29th at 1:00 p.m. in the high school library.

Evaluation Of Health Services

Mrs. Lindi Rogers gave an overview of the Health Clinic and Nursing department. Last year from September through March the clinics at the high school and elementary saw over 6400 students. Over 2000 of those visits were daily medication distribution. Mrs. Rogers works full time covering the clinic, making sure there is appropriate coverage at both schools, supervises the other nurses, tracks immunizations, Covid 19 duties, etc. She also serves as head of the Wellness committee and serves on other committees as needed.

MSBA Policy This was the second reading of Title IX Policies changes.

Future Facilities Planning

Mrs. Butler would like to see a committee initiated to begin discussions about the future needs of the Lone Jack School District.

CSIP Update

A CSIP meeting was held September 28th. The committee is trying to look past COVID and talk about the future. The group is using the MSIP 6 indicators and the Blue Ribbon school criteria as resources to generate goals and action steps.

Athletic Fields

Discussions were held regarding the athletic fields and who should be responsible for maintenance and upkeep of these fields. It was the general consensus that the coaches and teams would be responsible for maintaining and lining the fields. The board suggested the teams have a work day before the season to get the fields in order for the season to start. The possibility of adding a turf field at the high school was also discussed and will be discussed further.

Reopening Of School

Mrs. Butler has begun working with the other administrators and staff on how and when we will reopen. Data will be gathered over the next month based upon feedback from families and staff members, as well as reviewing what surrounding and conference schools are doing.

Surplus Property

Danny Barker moved to declare 50 Dell Laptops and 27 Promethean Boards as surplus property. Mark Smith seconded the motion. President Roth announced the motion carried 6-0.

MSBA Policies Danny Barker moved to approve the MSBA Policies 2019-C and 2020-A as recommended by Mrs. Butler. Mark Smith seconded the motion. President Roth announced the motion carried 6-0.

Admin Reports Mrs. Butler reported that enrollment is up approximately 2% this year.

Mrs. Butler also reviewed the Budget Quick Look. Expenditures are about 2% less than this time last year, but revenues are also down from previous years, due to Covid withholdings. The USDA has announced that the free lunch program will continue through September 30th, 2021. Ingram's Magazine ranked Lone Jack 21st in Missouri out of all the schools in 22 surrounding counties. First Student received a 100% score on their maintenance programing during the 2020 inspections. The high school and middle school admin reports were included in the board packet.
