Safety and Protocols

A Director Advisory team is being formed to start looking at the Safety needs and protocols of the district, along with some other initiatives. At least two district staff members will be trained to facilitate this process.

Elementary Construction

There are 2 weather days left but the project seems to still be on schedule for a July completion. The next two weeks plans are to finish building walls and waterproof exterior walls.

Admin Reports

Dr. Cygan reported that the elementary has been very active, celebrating 3 spirit weeks in a row. Early learning enrollment for the fall has begun. Mrs. Fenton will be teaching a morning and afternoon class next year (20 students in the morning and 10 in the afternoon). There are still two openings left for the afternoon class. Mrs. Moberly will also have a morning and afternoon class of 20 each. There are still 11 afternoon openings. Aimsweb assessments are indicating that students are closing the gap from last year's virtual instruction.

The number of students testing below grade level are small in all grades. April 5th will be next PD day.

Mr. Brendel reported that research is being done on adding Aimsweb assessments to the middle school curriculum. Middle school track practice has begun and there are 13 more students out this year than last year. Three additional students are moving from full virtual to in class instruction. Mrs. Martin and Mrs. Alumbaugh were recipients of mini grants this semester. Mr. Brendel will be attending the middle school principal conference in late March.

Mr. Fenstermaker reported that he and the counseling office have been working primarily on scheduling. Starting in the 2021-2022 school year there will be a honors track for history classes as well as starting with Freshman science. High school and middle school teachers will also be having PD on 4/5. The juniors are preparing for the district ACT test March 30th.

Mrs. Stockhorst reported that they too are working to make sure all students have the proper schedules for next year. Mrs. Stockhorst has been able to get all test protocols they use to determine student eligibility and needs in digital form. Student can now take the tests using an Ipad and it is graded automatically. This will help reduce testing time and manpower.

Mr. Pannett reported that the school has received cameras through a grant will which automatically live stream all home activities. Practices and games will be uploaded to HUDL for coach and team review. All sports participation is up with the exception of baseball.

Mrs. Butler reported that on March 9th, the PTO will be hosting a Meet the Candidate Forum at the elementary school. All candidates will have the opportunity to answer questions. The faculty is invited to a vaccination clinic on March 20th. Mrs. Rogers will be working the clinic so that we can offer these vaccines to the staff. Jackson County has updated their protocols regarding COVID which will potentially allow for more activities and events. The budget quick look was reviewed. Revenues are consistent with past years, however the sources of revenue have changed. Expenditures are also consistent with previous years. The insurance renewal came in with a 6% increase, with seems standard for most schools this year. Mrs. Bulter met with OPS representatives regarding custodial and maintenance improvements. Plumbing issues in the primary and high school due to freezinghave been submitted to insurance company and repairs are being bid.
