MSBA Policies The second reading of the 2021C Policy revisions was completed.

Activity Sponsorship Mr. Muckey and Mr. Pannett described a plan to solicit local businesses for local sponsorship and advertisement at the football field, softball and baseball fields and elementary and high school gymnasium. This would be a three year sponsorship and renewable at the end of each three year period.

Sewer Project MKEC has developed the design documents for the sewer project at the high school. Pre-bid meeting will be held December 22nd. Bids opening be January 5th and the bids will be presented to the board for approval at the January 10th board meeting.

CSIP Plan A draft of the new CSIP plan will be presented to the board at the January Meeting for approval.

RootEd Initiative Lone Jack has been selected to be a part of a Missouri Postsecondary Advising initiative. The initiative proves grant money will allow the district to employ Another guidance department part-time employee to work with scheduling and support for 9 – 12 graders.
