9. Elementary Principal's Report/Curriculum Coordinator's Report

Bradford was present to talk about the upcoming ISASP testing, the recent and schoolwide Kagan professional development training, the great turnout of the annual Family Fun Night, the completion of the teacher evaluations for the year, and an upcoming author visit on April 27th.

4. Review FY21 Aid and Levy and Budget Info

Heller and Hosch walked through the main areas of the FY21 budget they have been working on. They went over the management levy, categorical spending, and the proposed budget to be published in a few weeks. This year's tax rate is 11.78, and next year's will be 10.88. The public hearing for next year's budget will take place April 6th at 6:30 PM.

5. Review the Unofficial 2020 Revenue Purpose Statement Canvases for Buchanan, Fayette and Clayton Counties

Heller reviewed the unofficial results from the recent revenue purpose statement election for all 4 counties. 95.5% of the voters voted for Starmont to renew their revenue purpose statement, so thank you to all for taking the time to vote!

Koppenhaver gave her monthly update on goals, attendance, discipline and F's. Whittle gave thanks and recognition to all the workers during the winter sports season. A friendly reminder that the school's annual fish fry will be on Friday, April 3rd from 4:30-7:30 PM.
