### **Reports, Communications and Announcements**

The board received reports from our Finance Committee and Buildings and Grounds Committee.

### **Action Items**

Mr. Howell made a motion to approve first reading of Preschool, Elementary, Middle School, and High School Student Handbook changes for 2024-2025. Mrs. Willis seconded the motion. Motion carried 5-0.

Mrs. Shelton made a motion to approve the shared contract, appendix A with Chariton Community Schools and the Greater Prairie AEA for service of librarian. Bryna Walker will provide librarian services during the 2024-2025 school year for 1 day per week. Chariton shall pay Great Prairie AEA \$22,000 for librarian services for the 24-25 school year.

Mr. Dachenbach made a motion to shared contract, appendix A with Chariton Community Schools and the Greater Prairie AEA for service of Social Worker. Carie Masters will provide social worker services during the 2024-2025 school year for 1 day per week. Chariton shall pay Great Prairie AEA \$22,000 for social work services for the 24-25 school year. Mrs. Willis seconded the motion. Motion carried 5-0.

Mrs. Shelton made a motion to approve the *first* reading of board policy 710.4. Our food service director, Karla Trenary, reviewed this policy and recommended these changes. Our policy committee also reviewed it. Mrs. Willis seconded the motion. Motion carried 5-0.

Mr. Howell made a motion to approve the Advertising Rights Agreement with KIIC. Mr. Dachenbach seconded the motion. Motion carried 5-0.

Mr. Howell made a motion to ratify and approve the previous superintendent contract dated May 12, 2023 and make the superintendent whole for the \$22.03 monthly difference, a total of \$264.36, in annuity contributions from the 23-24 school year. Mrs. Shelton seconded the motion. Motion carried 5-0.
