- 1. Lucas County Economic Development presentation on the <u>Yocom Park Project</u>.
- 2. Approve the *first* reading of Board Policies <u>300-302</u>.
- 3. Approve Modified Allowable Growth Dropout Prevention Application Dropout Prevention modified supplemental amount (MSA) grants the district the spending authority for the Dropout/At-Risk program. Dropout Prevention is funded by a 75% grant of spending authority that gets funded by local taxes and 25% by district provided matching funds. This request allows the district to include the full amount in the budget for FY 2026, the upcoming fiscal year. This is an annual process the district must go through to receive the funds. The requested amount for the at-risk/dropout prevention program levy is \$278,836. This is an increase from last year where we asked for \$270,112.
- 4. Approve <u>Pay App No. 5</u>, <u>Pay App No. 6</u>, and <u>Pay App No. 7</u> to Dahl Air Conditioning and Heating for the Columbus & Van Allen HVAC Upgrades.
- 5. Approve Pay App No. 5 to Excel Mechanical for the HS HVAC Controls Replacement Project.
- 6. Consider approving the bus bid from Hoglund for three (3) 65-passenger buses for \$412,296 (\$137,432/per bus) and the bus bid from Bluebird for one (1) 84-passenger bus for \$209,010.00.
