The Board of Education of the Corning Community Schools met in regular session on Monday, March 14, 2025. The meeting was called to order at 7:15 p.m. by the President, Staci Venteicher. Jodi Lyddon presented the 2023-2024 Audit Report. Adam Hawxby and Ryan Nelson from Estes Construction shared updates on the construction project. Ryan Nelson presented change orders for the project. Dan Ahrens shared results from the FBLA State Leadership Conference. Eleven students qualified for FBLA Nationals. Superintendent Fenster reported on legislative action on SSA, operational sharing, and cell phone policy and updated the board on teacher openings and replacement of light poles at the softball field.
