Moved by Boswell seconded by Shuey to approve the 2025-2026 At Risk/Drop Out Prevention Plan and budget as presented. Carried Unanimously.

Moved by Roberts seconded by Hodapp that the district's administration is authorized to submit a request to the School Budget Review Committee for a modified supplemental amount of \$139,593 with a required local match of \$46,531 for the purpose of the At Risk/Dropout Prevention Program. Carried Unanimously.

Moved by Hodapp seconded by Roberts appointing President Venteicher and Vice-President Boswell to serve on the Whole Grade Sharing Liaison Committee for the 2025-2026 school year. Carried Unanimously.

Moved by Roberts seconded by Boswell to direct the superintendent to advertise and request bids for snow removal. Carried Unanimously.

Moved by Hodapp seconded by Boswell to approve the bid packages as complete for A-One Geothermal, Inc., Yates and Yates Glass, US Erectors, Inc., PDM Precast, Inc., Graphite Construction Group, Inc., Keul Electric, LLC, H2I Group, Blackhawk Roof Company, Inc., Boyd Construction, LLC, and Fire Protection Professionals, LLC. Carried Unanimously.
