1. Call to Order

The Starmont Community School District Board held a special, teleconference board meeting on Wednesday, May 29, 2024, in the Superintendent's office, located in the high school. 2. Approve Agenda

Motion by Uhlenkamp to approve agenda as presented. Seconded by Althoff. Motion carried 4-0.

3. Public Hearing - FY24 Budget Amendment

President Recker opened the public hearing for the FY24 budget amendment at 12:02 pm. There were no public comments. Recker closed the public hearing at 12:04 pm.

4. Approve FY24 Budget Amendment

Motion by Althoff to adopt the FY24 Budget Amendment as presented. Seconded by Moellers. Motion carried 4-0.

5. Approve Flooring Improvements

Motion by Uhlenkamp to approve Kluesner Flooring bid in the amount of \$34,514.24. Seconded by Moellers. Motion carried 4-0.

6. Approve Purchase of Replacement Water Heater

Motion by Moellers to approve purchase of 81-gallon water heater and (2) 120-gallon storage tanks from Arlington Heating & Cooling in the amount of \$23,000. Seconded by Althoff. Motion carried 4-0.

7. Approve Purchase of Basketball Shooting Machine

Motion by Moellers to approve purchase of basketball shooting machine in the amount of \$6,251. Seconded by Uhlenkamp. Motion carried 4-0.

8. Adjourn

Motion by Moellers to adjourn. Seconded by Uhlenkamp. Motion carried 4-0. Meeting adjourned at 12:10 pm.
