Call to Order: Ronnie Boardman called the meeting to order at 5:34pm.

Previous Minutes: Motion to approve previous minutes from May by Hillary, 2nd by Terry. All in favor.

Treasurers Report: Hillary reviewed accounts. A recent memorial fund has provided us with an additional \$1,840 to use. Trees have been planted at the golf course and the school board approved a proposal to dress up the football entrance with the remaining funds. Banner campaign letters have been sent out and follow up with businesses is next. A motion was made to approve the treasurer's report by Abbie. 2nd by Brittany.

Presidents Report:

- Golf outing will be at noon on August 17. Sign-ups are out at the golf course. It will be advertised in the community in July.

AD's Comments-

1. The cost for welding materials for the rack for the new padded chairs has been covered by several other student organizations. It is still being put together by the shop classes.
2. The score table benches have been reupholstered and paid for the Junior Stars and wrestling programs.

Old Business

1. Baseball Concession Stand Update: Trim and touch-up paint still needs to be finished. Discussion about a dedication plaque will be held this fall to recognize everyone who helped with the project.
2. Cement at Football Stand: The pre-application for the grant to pour new cement at the football stand to make things accessible was approved. Received one quote from a local contractor. Need approximately 2 more and then will finish the application.
3. Fall Sports Opening Event: postpone this discussion until after summer sports
4. Banner campaign: Letters have been sent to local businesses. Follow-up will be coming soon. 16 have already been returned.
5. Golf Outing: Menu will be decided at the next meeting and hole sponsors will be discussed.
6. Dividing responsibilities: Table until July.

7. Speakers: The project is finished at baseball and there have been lots of comments about how great it sounds and adds to the atmosphere. The softball program has declined to add speakers at this time.

New Business

1. Roger Reed presented a proposal with drawings on how to revitalize the football/track entrance as well as adding bricks and new pavement along the sidewalk entrance. The Booster Club is in agreement with pursuing how to begin the project.
2. Football Cheerleading Uniforms: Football cheer has recently been approved by the school board and are in need of uniforms before the fall season. Ronnie and Tracy will check with the school on how to get it on the uniform rotation schedule. A motion was made by Hillary to allow the purchase of up to \$1000 in uniforms by the football cheer program to be paid back when the group is able to fundraise. 2nd by Brittany.
