Call to Order: Ronnie Boardman called the meeting to order at 6:02pm.

Previous Minutes: Motion to approve previous minutes from June by Hillary, 2nd by Ron. All in favor.

Treasurers Report: Hillary reviewed accounts. A motion was made to approve the treasurer's report by Terry. 2nd by Brittany.

Presidents Report:

AD's Comments-

1. The softball program is requesting funds to purchase a pitching machine that throws a variety of types of pitches for the amount of \$2600. A motion was made to approve the purchase of the pitching machine for \$2600 by Hillary, 2nd by Terry.
2. The school is hosting a meeting for coaches and sponsors on August 3rd and is requesting that the Booster Club purchase pizzas and provide drinks for the meeting. The group agreed to provide pizzas and drinks.

Old Business

1. Baseball Concession Stand Update: The air conditioner is not working. Terry will check into where it was purchased to see if there is a warranty.
2. Cement at Football Stand: Three bids for cement were discussed. The group will decide on a bid and finish the grant application before August 29th.
3. Banner campaign: Letters have been sent to local businesses. Several still need to be followed up on and banners need to be ordered.
4. Golf Outing: Menu will be brat patties and chicken breast. Drinks and food need to be ordered for delivery by August 14th. Hole sponsors were divided up and will be contacted in the next week. Golf balls will be ordered. Cost of the tournament will be raised to \$30 per golfer. The high school golf team discussed having a fundraiser at the tournament.
5. Revitalizing Football/Track Entrance: Building materials have been ordered and should be delivered soon. The expectation is that the ticket booth will be finished by the first game. The entrance pillars will be completed next spring.

New Business

1. Pepsi Contract: Discussed signing a new contract to serve Pepsi products in the outdoor stands. The group chose to take the rebate option. The contract now needs to be signed and submitted to the vendor.
2. Football Captains: Captains were assigned for each home varsity, junior varsity, and junior high games.
3. Concession Stand Workers: Discussed offering the opportunity to work home football games in exchange for a set amount of funds to be placed in student group accounts. Jen will present the option at the upcoming coaches meeting.
4. Popcorn machine: The baseball popcorn machine broke during the season and is no longer usable. A new one needs to be purchased. A motion was made to purchase a new popcorn machine for \$1879 + tax by Jen, 2nd by Terry.
5. Open House/School Registration: Registration is set for August 4th. The Booster Club will set up a table from 12-7.
6. Internet and card reader in football stand: Discussion about adding internet and card readers for football games as some people do not carry cash. Hillary will check into options with the school.
